#### 4. EXECUTIVE DIRECTOR REPORT

Executive Director Dawn Arthur provided her ED Report starting with a snapshot with the Life of the School and various social and academic activities taking place

Ms. Arthur discussed RISE enrollment and attrition, providing a deeper discussion on why families were leaving, at the board's request. Most have had to do with moving, other factors have been cultural fit. Ms. Arthur has been involved in those discussion with families to understand why families have left or are seeking other opportunities.

Ms. Arthur also provided an update on Benchmark results. There are interventions needed and will be worked in and discussed with teachers during professional development. Staff needs more time to work in the data to determine if big strategic moves or incremental changes should be made before the end of the year to target end of grade growth.
