#### 1. CALL TO ORDER AND ROLL CALL

#### **Executive Director Update:**

Executive Director Dawn Arthur advised that a full Executive Director report will be provided at the full Board meeting in March where fall and winter benchmark scores can be shared. Ms. Arthur provided an update on attendance and the school strategy in addressing the issue. Overall attendance has approved. Student recruitment is a priority and the leadership team is focusing on strategy. A financial update will be provided at the next meeting, since the Finance Committee will be meeting later on in the month.

Ms. Arthur discussed the schools new hires, survey response data from parents on reopening options and plans.

The proposed Reopening Plan for a targeted March 1, 2021 reopen date is as follows:

- Plan B or Modified Plan A
- To include buses and afterschool programming
- Greenlight app to be launched with families
- Continue to ready the school according to the Greenlight Playbook.

Ms. Arthur and Ms. Latoyia Kinsey, Principal, discussed the more significant challenge of improving the learning opportunities for all Pave scholars and strategies they plan to implement; including a five week Summer Learning Program, possible retention of more students in their current grade and development of vaccination plans/policies for fall 2021.

A motion was made by Tucker Mann to accept the Reopening Plan as presented by Pave Leadership (outlined above), it was seconded by Crawford Crenshaw and unanimously approved.

Committee Chairs will be invited to attend the next Pave Executive Committee meeting on February 8, 2021.
