1. CALL TO ORDER AND ROLL CALL

Crawford Crenshaw determined that the meeting was duly noticed and called the meeting to order at 1:05 pm.

Guest Craig Herb attended the meeting and all board members introduced themselves.

4. EXECUTIVE DIRECTOR REPORT

Executive Director Dawn Arthur began her presentation with again celebrating and acknowledging the academic strides that RISE scholars and educators made over the 2023-2024 school year. RISE achieved exceptional growth which changed the school rating from an F to a C; EOG scores indicated that RISE more than doubled the number of college ready scholars; and 5th and 8th grade achieved a greater than 72% proficiency in Science.

Instructional Insights:

- iReady results last year appeared correlated to EoG progress thereby helping to confirm that our testing tools are helpful in monitoring progress and targeting instruction
- Starting BoY proficiency, 3-8 (tested grades), is stronger than K-2 (foundations)
- However, by EoY, Kindergarten had demonstrated the strongest conversion of proficiency scholars (84% in reading in math).

Financial Insights:

- Our BoY enrollment was 483 last year, and will be about 485 this year.
- 2023-24 was our final year of covid relief funding (ESSER = 1.3M over 3 years)

- We used ~600K in cash reserves to support costs (see above plus deficit)
- Overage has led to cuts in staffing and may require more.
- Audit likely 'sound' with findings or recommendations: concussion, licensure, ctr. clause

Needs Remain:

Ms. Arthur highlighted again school needs for vibrant and safe play areas, functional and inviting bathrooms and stairwells, K-5 storage and 6-9 lockers, sound management, stage curtain, A/V and gymnasium updates.

Mr. Arthur further provided an update on the Renewal items that have been completed and those that need attention and ways for the board to engage with the RISE community.
